Loan of an instrument is subject to the following conditions:

1. All instruments under this agreement remain the property of Camira State School and must be returned to the school at the end of Semester II or on a date set by the teacher.
2. The instrument is returnable on demand at any time for inspection, repair, and adjustment or for any other reason.
3. The instrument is to be used by the student to whom it is loaned and by no other person.
4. Every care and attention must be given to the instrument during the period of the loan. In the event of loss or damage, the matter must be reported to the school immediately.
5. Parents/guardians may be responsible for the cost of repair and replacement of any lost or damaged instruments. Please check with your own insurers as these risks may be able to be minimised through your existing Home Contents Insurance.
6. If, in the opinion of the teacher, a student is not carrying out reasonable practice or shows little ability with the instrument, the loan may be terminated.
7. If a student does not observe school policy on attendance at rehearsals, the loan may be terminated.
8. Every student that enrolls in the Instrumental Music program must pay a levy fee of \$20 **regardless of whether they are hiring or providing their own instrument**. Students that are hiring an instrument through the air wear and tear is expected and for the duration this transfer I/we agree to indemnify the department of education and training against loss or damage from any cause whatsoever to the equipment detailed herein and in the event of damage to restore and deliver such equipment to the department of education and in the condition in which it was received or to replace the damaged equipment with other equipment of equivalent functionality.
